Cautions including any relevant action to be taken	<ul style="list-style-type: none"> • Perforation of eardrum • Avoid prolonged use <p>Monitor for sensitivity reactions.</p> <p>Staff Advice - Consult medical advice if an adverse event occurs. Storage	<ul style="list-style-type: none"> Once opened, use within 30 days – label with Date, Time and Initials of who has issued it. Stock must be securely stored according to UHDB medicines policy and in conditions in line with SPC as detailed below: Store at a temperature not exceeding 25°C. Avoid freezing. Always replace the bottle back in the carton after use to protect its contents from light.

Serious adverse reactions (moderate harm or above as per NRLS definition) should be reported via trust incident management system (e.g. Datix) to ensure duty of candour and learning from harm during clinical use. <p>Records</p>	<p>Details of the supply must be recorded in the patient's health records and in a drug record stock book kept in the ENT Clinic. State "administered under PGD" with name and signature of authorised nurse. A second check should be obtained from a qualified healthcare practitioner before administration.</p> <p>For EPMA: Document the utilisation of the medicine under PGD by ordering the appropriate drug order item against the correct patient record in Nursing notes, Cito or V6.</p> <p>Either the system holding the record, or the healthcare practitioner working under the PGD, must capture/document all of the following:</p> <ul style="list-style-type: none"> • name of individual, address, date of birth and GP with whom the individual is registered (if relevant) • name of registered health professional • name of medication supplied/administered • date of supply/administration • dose, form and route of supply/administration • quantity supplied/administered • batch number and expiry date (if applicable e.g. injections and implants) • advice given, including advice given if excluded or declines treatment • details of any adverse drug reactions and actions taken • Confirm whether <u>supplied and/or administered</u> via Patient Group Direction (PGD) <p>Records should be signed and dated (or a password controlled e-records).
